NPRC HITS THE ROAD

Northern Pennsylvania Regional College was a recipient of a \$250,000 grant from the Appalachian Regional Commission (ARC). This grant is being allocated to the purchase of two customized and branded vans to assist the College's various needs, including instructional and student service support.

One van will be designated to haul equipment throughout our footprint to support labs and training programs, making hands-on learning more accessible for our region. The second van will be designed with more flexible, multi-purpose use to support various academics, workforce development, and student services activities. This vehicle will serve as a mobile space that helps facilitate convenient access to potential training aids, smaller lab equipment, and NPRC's planned career closet. This van will also provide our team's transportation to off-site programming, while providing static recruitment and visibility opportunities.

NPRC AND EC3 JOIN FORCES

Northern Pennsylvania Regional College and Erie County Community College signed an academic agreement to aid current and future students in their academic journeys between institutions. Leadership from the respective institutions met at the Corry Higher Education Council on Tuesday, October 3 for a formal event to sign the agreement into effect. Each institution will begin honoring course equivalencies as soon as the spring 2024 term, with the formal agreement going into effect in Fall 2024.

This agreement has a goal of better serving students who are currently residing or may reside in Erie County in the future, and helps ensure clear communication regarding courses and programs at each institution and creates more seamless transferability. The agreement will be honored for five years, with consistent review of course equivalencies will occur.

NPRC HOSTS PARAPROFESSIONALS PATHWAY PROGRAM

Seneca Highlands Intermediate Unit IX (IU9) has selected NPRC as the two-year educational provider for the Paraprofessionals Pathway Program. This program will begin at the start of the Spring 2024 term, and is designed to assist current paraprofessionals in the IU9 service area with earning valuable special education preparedness.

The program was made possible after IU9 was awarded the Paraeducator Preparation Pathways grant funding through a program from Governor Shapiro. The grant provides \$1.5 million statewide for paraeducators to enhance their special education credentials and knowledge. To support this program and its goals, NPRC is also offering a new specialization in special education as part of the early childhood education program in the 2024-25 academic year.

RURAL BROADBAND FORUM RECAP

NPRC hosted a panel of representatives from various state and federal agencies for a Rural Broadband Forum on Monday, October 30 in Coudersport. The event provided important information on the Broadband Equity Access and Deployment (BEAD) Program.

The BEAD Program is a nationwide initiative to help underserved communities have improved internet access and speed, cybersecurity, infrastructure, and related technological improvements. This nearly 50-billion-dollar program awarded \$1.16 billion to the state of Pennsylvania; with the Pennsylvania Broadband Authority tasked with allocation.

This event shared opportunities for funding, updated infrastructure, and workforce development enhancements in underserved areas across the state. Area business owners, economic development organizations, legislators, and even curious community members attended to better understand how the BEAD Program can make an impact.

From improved internet access and speed for small town residents to new and updated infrastructure creating possible opportunities for employment, we look forward to seeing the progress of this initiative.

DAVE WILSON PRESENTS AT NATIONAL CONFERENCE

Instructor of Criminal Justice, Dave Wilson, presented at the Law and Public Safety Education Network (LAPSEN) National Conference in Phoenix, Arizona this past November. Wilson presented about the new criminal law course he developed and



teaches at the College; a course prioritizing investigation scenarios.

The new criminal law course was introduced to students this past spring after the separation of the original criminal law and procedure course. This action split law and procedure into independent classes allowing Wilson to design a course with an extensive final project involving criminal elements and the charging of a suspect. In the new course, students follow the steps involved in investigation and write an incident report, file for a search warrant, and present their findings and procedure to a panel of highly qualified professionals that has included district judges and local attorneys.

"It means a lot to be seen as an educational leader in criminal justice both personally and as an institution. To be sought out by LAPSEN to present at this conference and share about the steps we have taken as an institution was a privilege."

BRIAN BYERS, LEAD EMS INSTRUCTOR
