<p><b>Class Schedule</b></p> <ul style="list-style-type: none"> <li>- 160 hours of training which includes ELDT and BTW training.</li> <li>- One class a month is offered in Erie, St. Marys, and Mansfield.</li> <li>- The class will run with a minimum of three and a maximum of four students.</li> <li>- If there are not enough students for the class to run, the students and if applicable their CareerLink representative will be notified. Students have the option to transfer to the next available class at no charge.</li> </ul>	<p><b>Class Schedule</b></p> <ul style="list-style-type: none"> <li>- 40 hours of self-paced online ELDT training</li> <li>- 40 hours of one-on-one behind-the-wheel (BTW) training in Tionesta scheduled 15 days after Class A Temporary Permit is acquired.</li> <li>- BTW training will be scheduled by the student directly with CNB Wagner staff.</li> </ul>

<p><b>Refund Policy</b>  <a href="#">NPRC-8420</a></p>	<p><b>Refund Policy</b>            Self-Payers: Once BTW training is scheduled, students must complete training on scheduled dates. If students do not complete the training on the dates agreed upon with CNB Wagner, they will be charged a \$1,500.00 scheduling fee and will only be refunded \$3,000. If they wish to re-schedule BTW training, they will owe an additional \$1,500 scheduling fee.</p> <p>State-Funded Payors: Students may re-schedule BTW training with no penalty in special circumstances only.</p>
